



### Modified Stage 2 Meaningful Use: 2015-2017

<p>Modified Stage 2 meaningful use requires physicians to meet and attest to all objectives. Remember to document everything in the event of an audit.</p>		<p><b>*Exclusions available</b></p>
<p><b>Objective 1: Protect Patient Health Information</b></p>	<p>Protect electronic health information created or maintained by the EHR. Conduct or review a security risk analysis, including addressing the encryption/security of data at rest and implement security updates as necessary. Correct identified security deficiencies as part of risk management process.</p>	
<p><b>Objective 2: Clinical Decision Support</b></p>	<p><b>1)</b> Implement <u>five</u> clinical decision support interventions related to four or more clinical quality measures at a relevant point in patient care for the entire EHR reporting period.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> Implement <u>one</u> clinical decision support rule relevant to specialty or high clinical priority, along with the ability to track compliance with that rule.</p> <p><b>2)</b> Enable the functionality for drug-drug and drug-allergy interaction checks for the entire EHR reporting period.</p>	<p>✓</p>
<p><b>Objective 3: Computerized Provider Order Entry (CPOE)</b></p>	<p>Use computerized provider order entry (CPOE) for medication, laboratory and radiology orders created during the EHR reporting period.</p> <p><b>1) <u>More than 60%</u> of medication orders</b></p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> Use CPOE for <u>more than 30%</u> of unique patients with at least one medication in their medication list; <i>or</i> <u>more than 30%</u> of medication orders created during the EHR reporting period are recorded using CPOE.</p> <p><b>2) <u>More than 30%</u> of laboratory orders</b></p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion for laboratory orders for an EHR reporting period in 2015</p> <p><b>3) <u>More than 30%</u> of radiology orders</b></p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion for laboratory orders for an EHR reporting period in 2015</p>	<p>✓</p>
<p><b>Objective 4: E-prescribing</b></p>	<p>Generate, compare with at least one drug formulary, and transmit <u>more than 50%</u> of all permissible prescriptions.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> Generate and transmit permissible prescriptions electronically for <u>more than 40%</u> of all permissible prescriptions.</p>	<p>✓</p>
<p><b>Objective 5: Health Information Exchange</b></p>	<p><b>1)</b> Use a certified EHR to create a summary of care record <b>2)</b> Electronically transmit the summary of care to a receiving provider for <u>more than 10%</u> of transitions of care and referrals.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion - there is no equivalent measure for Stage 1</p>	<p>✓</p>
<p><b>Objective 6: Patient Education</b></p>	<p>Use the EHR to identify and provide patient-specific education resources to the patient for <u>more than 10%</u> of all unique patients seen during the EHR reporting period.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion if the patient education menu objective was unintentionally selected</p>	<p>✓</p>

<p><b>Objective 7: Medication Reconciliation</b></p>	<p>Perform medication reconciliation for <u>more than 50%</u> of transitions of care in which the patient is transitioned into the care of the physician.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion if the medication reconciliation menu objective was unintentionally selected</p>	<p>✓</p>
<p><b>Objective 8: Patient Electronic Access / View, Download, Transmit (VDT)</b></p>	<p><b>1)</b> Provide online access within <u>4 business days</u>, for <u>more than 50%</u> of all unique patients, to their health information.</p> <p>For 2015 and 2016: <b>2)</b> At least <u>one patient</u> seen during the EHR reporting period must view, download, or transmit to a third party their health information.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion for the second measure, which does not have an equivalent measure</p> <p>For 2017: <b>2)</b> <u>More than 5%</u> of patients seen during the EHR reporting period must view, download, or transmit to a third party their health information.</p>	<p>✓</p>
<p><b>Objective 9: Secure patient messaging</b></p>	<p>For 2015: For an EHR reporting period, the capability for patients to send and receive a secure electronic message with the provider was fully enabled.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> May claim an exclusion - there is no equivalent measure for Stage 1</p> <p>For 2016: For <u>at least one</u> patient seen during the EHR reporting period, a secure message was sent using the electronic messaging function of the certified EHR, or in response to a secure message sent by the patient.</p> <p>For 2017: A secure message was sent using the EHR secure messaging function by <u>more than 5%</u> of unique patients seen during EHR reporting period.</p>	<p>✓</p>
<p><b>Objective 10: Public Health Reporting</b></p>	<p>Meet <u>at least two</u> of the public health measures listed below: <b>1)</b> Immunization Registry Reporting - Be actively engaged with a public health agency to submit immunization data. <b>2)</b> Syndromic Surveillance Reporting - Be actively engaged with a public health agency to submit syndromic surveillance data. <b>3)</b> Specialized Registry Reporting - Be actively engaged with a specialized registry to submit data.</p> <p><i>Physicians scheduled to demonstrate Stage 1 in 2015 :</i> Meet <u>at least one</u> of the public health measures listed above.</p>	<p>✓</p>
<p><b>Clinical Quality Measures (CQMs)</b></p>	<p>As part of meeting meaningful use, physicians must report on 9 of the 64 CMS-approved clinical quality measures (CQMs). CQMs must be submitted electronically to CMS as part of the Medicare incentive program, and to Texas Medicaid for the Medicaid incentive program.
